Ayurved Mahavidyalaya, Shivaji Nagar, Arni Road, Dist. Yavatmal (Maharashtra) for Increase in Intake Capacity from 60 to 75 seats under EWS quota for B.A.M.S. (UG) course for the Academic Year 2019-20...
